Schedule 10, Reg 5.1.5 - Six (6) months between judging the same breed/group/group final at Championship Shows in any Province.

Schedule 10, Reg 5.1.6 – Six (6) months between judging Best Puppy In Show, Best In Show at all breeds Club Shows in any Province.

Schedule 10, Reg 5.1.1 – Three (3) months between judging the same group/group final at Non-Championship Shows in the same Province.

Schedule 10, Reg. 5.1.2 – No restriction between judging the same breed, group or group final at Non-Championship shows in different Provinces – provided both Clubs agree.

Schedule 10, Reg. 5.1.3 – Six (6) months between judging the same breed, group or group final between Non-Championship Show and a Championship or Qualifying Show in the same Province.

Schedule 10, Reg. 5.1.4 – Three (3) months between judging the same breed, group or group final at a Non-Championship and a Championship or Qualifying Show in different Provinces.

Schedule 5E Events – no restrictions

Working Disciplines – no restrictions
