1. The expenses shown above are subject to approval in advance by the Club conducting the Show.
2. If the Judge’s accommodation and/or expenses are not confirmed by the Club within _____ days (Insert No. of days) of the date of acceptance it will have deemed to have lapsed and the contract is at an end.
3. Air and other Travel. If a specified mode of travel, including conditional methods of air travel, is required or by a Judge these should be specified and full particulars of this travel should be given. In the absence of such specification a Judge is entitled to full Economy return air travel on the schedule specified by the Judge (N.B. the method and responsibility for booking and payment of fares should be clearly agreed upon by the parties to this contract.).
4. This show is being conducted under the Rules and Regulations of The Kennel Union of Southern Africa.
5. Judging is to be conducted to the recognised Regulations and Breed Standards of the Kennel Union of Southern Africa and the Judge undertakes that before judging, he or she will become fully conversant with and abide by such Rules and Regulations as may be relevant and the appropriate Breed Standards.
6. The Club will provide all overseas Judges free of charge copy of the appropriate KUSA Breed Standards, Rules and Regulations (Guide for Conformation Judges) applicable to the appointment.
7. The Judge to advise the Hon. Secretary of the Club whether or not this invitation is accepted. If the reply is not received by the Secretary of the Club within _____ days of the date of the offer it will have deemed to be lapsed (insert no. of days)
8. Any other terms specific to this Contract:
 - a) Not to judge the Breed/s/Group/Grades/Trials/Classes shows overleaf under the section marked “Appointment” for a period of _____ months before the Show detailed overleaf within the KUSA area of jurisdiction without the express approval of the Club offering this Contract.
 - b) Judges domiciled in the KUSA area of jurisdiction must be current members of KUSA at the time of accepting this invitation and at the time of Judging.

Judges are reminded that in terms of the KUSA Regulations given below a Judge may not judge the same breed/s/Group/s, Group Challenge/Finals as given below:

Schedule 10, Reg 5.1.5 - Six (6) months between judging the same breed/group/group final at Championship Shows in any Province.

Schedule 10, Reg 5.1.6 – Six (6) months between judging Best Puppy In Show, Best In Show at All Breeds Championship Shows in any Province.

Schedule 10, Reg 5.1.1 – Three (3) months between judging the same group/group final at Non-Championship Shows in the same Province.

Schedule 10, Reg. 5.1.2 – No restriction between judging the same breed, group or group final at Non-Championship shows in different Provinces – provided both Clubs agree.

Schedule 10, Reg. 5.1.3 – Six (6) months between judging the same breed, group or group final between Non-Championship Show and a Championship or Qualifying Show.

Schedule 10, Reg. 5.1.4 – Three (3) months between judging the same breed, group or group final at a Non-Championship and a Championship or Qualifying Show in different Provinces.

Schedule 5E – no restrictions

Working Disciplines – no restrictions

N.B. This Contract is to be forwarded to the Judge in duplicate. The Judge is to retain one copy and return the other completed copy to the Club in accordance with these terms and conditions.

This contract is offered on the terms and conditions as printed herewith and I accept these conditions in their entirety and await final notification from your Club when my qualifications have been cleared by the Kennel Union of Southern Africa.
