KUSA REGULATIONS FOR INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIALS (FCI-IGP) SCHEDULE 05B (02)

(Effective 01.10.2026)

This Schedule is to be read in conjunction with Appendix B – Regulations for International Working Dog Trials and International Tracking Dog Trials of the F.C.I. This Schedule describes Special KUSA Regulations as provided for by “Special Regulations: The LAO is entitled to expand (modify) general regulations for their area (country).”

When the guidelines, as issued by the FCI, are altered by the FCI for the exercises concerned then the KUSA will *mutatis mutandis* amend this for immediate implementation in the KUSA area of jurisdiction. Notwithstanding anything as issued by the FCI the provisions of this Schedule and the relative KUSA Schedule as laid down in the Constitution will apply.

1. LICENSING AND HOLDING OF FCI-IGP

1.1 Licensing and Show Regulations

The regulations relating to licensing and to all other matters to do with shows as set out in Schedule 3 (Championship Shows) and Schedule 4 (Non-Championship Shows) of the Constitution of the Kennel Union of Southern Africa (KUSA) shall apply to FCI-IGP as far as they can be relevant to FCI-IGP and as far as they do not conflict with the specific terms of Schedule 5B (2) (FCI-IGP).

1.2 Scope of Licence

The license may include any one or more of the following grades. All the exercises contained in the REGULATIONS FOR THE INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIAL OF THE FCI. They are effective from January 1st 2019. A club entitled to hold a Championship Show may hold a Championship FCI-IGP Show not more than once in any calendar year under the same license as a Championship Breed Show or under the same license as another Championship Event or under a separate license. Before applying to hold a Qualifying Show, a new Club must have held two (2) Non-Championship Shows. The provisions in Schedule 4A (Regulations for Qualifying Shows) shall apply to Qualifying Shows (FCI-IGP) as far as they can be relevant to FCI-IGP. The minimum number of dogs present and exhibited shall be as per the minimum number of dogs for a trial.

1.3 Marks, Qualifications and Rating

- 1.3.1 A dog can qualify in the different grades as set out in the Regulations for the International Utility Dog Trials and the International Tracking Dog Trial of the FCI. All the exercises contained in the REGULATIONS FOR THE INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIAL OF THE FCI at Non-Championship Shows. No certificate will be issued.
- 1.3.2 The owner of any dog may use only the most senior qualification achieved in abbreviated form, as an appendage to the dog's registered name. The abbreviations to be used are: (FCI-BH VT, FCI-IGP- ZTP, FCI-IGP VO, FCI-IGP 1, FCI-IGP 2, FCI-IGP 3, and FCI-IGP-FH1, FCI-IGP-FH2.) All the exercises contained in the REGULATIONS FOR THE INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIAL OF THE FCI In order to have the qualifications placed on any registration records, a copy of the (Workbook) Workbook must be submitted to the KUSA.

- 1.3.3 The points and ratings scored are not to be part of the dog's title or registered name.
 - 1.3.4 The dog must always compete in the highest trial grade reached, except when no placing or qualification is associated with the trial. This means that once a dog has competed in a grade, it can no longer compete in a lower grade.
- 1.4 FCI-IGP (SA) Champion**
- 1.4.1 The title FCI-IGP (SA) Champion to a dog that has received three (3) Qualifying certificates in FCI-IGP 3 from at least (two) 2 different KUSA Licensed FCI-IGP judges with a minimum score of 80 points in discipline A and B and minimum score of 90 in Discipline C and a TSB of Pronounced.
 - 1.4.2 The title FCI-IGP (SA) Champion shall be awarded to a dog that has been awarded the title KUSA National FCI-IGP Dog for..... (Year) and such dog shall receive a certificate to this effect from the KUSA.
- 1.5 Eligibility of Dogs for Competition**
- 1.5.1 Any dog registered or recorded by the KUSA may enter.
 - 1.5.2 No dog can be entered in any FCI-IGP Trial unless it has been issued with a (Dog Qualifying Workbook (FCI-IGP) KUSA, and no dog can be entered "Registration Applied For" (RAF), or "Transfer Applied For" (TAF), under the terms of Schedule 3, Regulation 7 where applicable.
- 1.6 KUSA Registered Helpers (IGP)**
- Schedule 05J – Regulations for KUSA Registered Helpers (IGP) applies.

2. MANAGEMENT OF FCI-IGP

2.1 Management of FCI-IGP

- 2.1.1 Trial Manager: The Trial Manager who shall be a member in good standing of the Kennel Union, will have made provision for sufficiently large terrains to hold all Phases of the trial. (Discipline A, tracking, at tracking grounds and Discipline B and C at one venue) and:
 - i) Have experienced volunteers available, such as helpers for protection, tracklayers, group, etc.
 - ii) Obtain event authorisation.
 - iii) Make available equipment to be used in the trials, e.g., hides, jumps and dumbbells.
 - iv) Make available the written forms such as judging sheets, trial lists for all grades etc.
 - v) Have available the scoresheets, workbooks etc.
- 2.1.2 Misbehaviour of Dogs at a Trial must be mentioned and reported to KUSA and NIGPSC by the Trial Manager within seven (7) days of the close of the Trial. This includes:
 - i) The dog bites the helper anywhere on the helper's body other than the protective sleeve provided for the grip.
 - ii) Dog in defence targeting another person (Judge, steward etc.) than the Helper.
 - iii) Dog attacking another dog.
 - iv) Unsportsmanlike behaviour of the handler (motivational objects or food).

- 2.1.2.1 In a case where the judge must submit a report to KUSA, such report shall be sent to the KUSA office within seven (7) days of the close of the trial.

2.2 Number of Dogs to be judged

- 2.2.1 If the number of entries is excessive, the committee of the Club holding the FCI-IGP trial shall appoint an extra Judge or Judges whose name/s shall be communicated to the KUSA for approval. This must satisfy the requirements of the FCI regulations for FCI-IGP trials of not more than 36 phases to be judged by any judge in one day.
- 2.2.2 In the situation described in 2.2.1 the Show Committee must allocate an entire "Phase" or "Phases" to be judged by the individual Judge as stipulated in the REGULATIONS FOR THE INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIALS OF THE FCI under trial judges, e.g. one Judge judges the complete Discipline A, another Judge judges the complete Discipline B, one or both Judges judge Discipline C. Any competitor qualifying under this Regulation will have his Work book and certificates signed by all the Judges who judged his dog.

2.3 General attitude and conduct of the Handlers

- 2.3.1 Either the owner or his deputy may handle the dog but it must be the one or the other. Once the dog has commenced work, an owner must not interfere with his dog if he has deputised another person to handle it.
- 2.3.2 The dog's (FCI-IGP Qualifying Work book) FCI-IGP Workbook has to be presented to the Trial Manager before the start of the trial.
- 2.3.3 In all exercises the left side of the Handler will be regarded as the working side. If the Handler suffers from a physical disability the Handler may work the dog on the right hand side, provided he notifies the Judge before the commencement of the judging at the trial.

2.4 Conditions

It is the responsibility of the Trial Manager and of the Judge/s to ensure that all dogs competing in a Grade compete under the same conditions as far as this is practical.

2.5 Weather

Cancellation of a Trial or any part of a Trial shall be at the discretion of the Trial Manager in consultation with the Judge/s.

2.6 Starting Time

All competitors shall be informed of the starting time of their Grade when judging commences, and competitors and dogs in each Grade shall be present at the site of a Trial at least thirty (30) minutes before that time. Any competitor who is not present thirty (30) minutes prior to the informed starting time may be considered by the Judge as withdrawn.

2.7 Order of competition

- 2.7.1 Void

- 2.7.2 Based on the initial draw in Grades 2 and 3 the competitors will be taken to the tracking ground in groups of three (3) or four (4), where a second draw will define the order of tracking for that group so that they are unaware of the specific Tracklayer whose track their dog will be required to follow. Communication with the Tracklayer is forbidden.

2.8 Tracklaying

No track shall be laid by a Tracklayer who is a member of the same household as the owner or the Handler of the dog. The age of the track is to be calculated from the time the Tracklayer commences the laying of the track.

2.9 Helpers (FCI-IGP)

Only Registered Helpers (FCI-IGP) may assist at any FCI-IGP Trial. Before approving a foreign Helper (FCI-IGP), the KUSA shall be satisfied that such Helper is recognized and approved in his country of permanent residence.

The only helpers permitted to officiate at KUSA FCI-IGP trials are:

2.9.1 KUSA Registered helpers.

2.9.2 Helpers registered with any FCI affiliated organization.

Helpers will be subject to confirmation from the organization to which they are registered.

2.10 Competition by Officials at Shows

A KUSA Representative may not enter, exhibit or handle a dog registered in his name at any KUSA Licensed event held at the same venue on the day that he is officiating, nor in the same Discipline held under the same licence on any day.

2.11 Catalogue Numbers

Handlers must display catalogue or entry numbers prominently on their person when competing.

2.12 Gunshot steadiness tests

Where tests are conducted that require the firing of shots, it should be noted that the 'gun' used must be a suitable starter's pistol, electronic starter's pistol, cap gun, blank pistol or suitable gunshot simulator app. Under no circumstances may live ammunition be used. Effective ear protection must be worn by the person firing the gun, e.g. earmuffs, headphones or earplugs (inserts).

3. JUDGING FCI-IGP

3.1 Knowledge of Regulations

All Handlers are expected to have a thorough knowledge of the Regulations for the Grade in which they are competing.

3.2 Dogs tested separately

Each competing dog will be tested separately except where the Description of Exercises specifically provides otherwise.

3.3 Judging Appointments

- 3.3.1 In the event of any KUSA FCI-IGP Judge not carrying out an FCI-IGP judging appointment for a period of three (3) years or more, he will be required to act as a Learner Judge (FCI-IGP) once with a KUSA Licensed Judge (FCI-IGP) and submit one (1) satisfactory report to the officiating KUSA Licensed Judge (FCI-IGP) before he can accept a further FCI-IGP judging appointment.
- 3.3.2 FCI-IGP Licensed Judges are required to attend at least one Refresher Seminar every 3 years to maintain their Judging Status. (In the event of any KUSA FCI-IGP Judge not attending a Refresher Seminar in a 3 year period or longer, he or she will be required to act as a Learner (FCI-IGP) Judge once with a KUSA Licensed Judge (FCI-IGP) and submit one (1) satisfactory Report to the officiating KUSA Licensed Judge (FCI-IGP) before he or she can accept a further FCI-IGP Judging appointment).
- 3.3.4 A Judge may refuse to proceed with judging if the correct procedures of the FCI FCI-IGP regulations are not adhered to.
- 3.3.5 The FCI section headed "Trial Judges" states that "Any form of criticism regarding the evaluation can lead to dismissal from the site..." Under KUSA regulations this may lead to a report by the Judge of unsporting behaviour.
- 3.3.6 The FCI section headed "Trial Judges" describes the procedure for submitting a complaint and states that "In justified cases, regarding a violation of the trial regulations on the judge's part and not a judge's decision, a complaint can be filed within eight days."

This FCI ruling is invalid, as it is in conflict with the KUSA regulations for complaints about shows.
- 3.3.7 Where there is a conflict between the Regulations for the International Utility Dog Trials and the International Tracking Dog Trial of the FCI and KUSA Schedules and administration, the KUSA Regulations will apply insofar as they do not alter the FCI FCI-IGP Trial rules.
- 3.3.8 An IGP Judge will become inactive if he/she is not physically capable of following the dogs on the tracking field.

3.4 Intervals

No mandatory intervals are required between judging appointments.

3.5 Uniformity

For the purpose of international uniformity the method of judging must remain within the spirit of these Regulations.

- 3.5.1 The Judge must adhere to the specific directives for evaluation which are given in the Description of Exercises.
- 3.5.2 All dogs which qualify shall be placed in preference to any dog which has not qualified, although the unqualified dog may have scored a higher aggregate of marks in the Grade.

- 3.5.3 The Judge must keep himself familiar with rule changes.

3.6 Qualification and Training for National Organization Judges

- 3.6.1 For the purpose of this regulation the term "Learner Judge" means a person not yet qualified to judge at a particular trial and who accompanies the appointed International FCI-IGP licensed Judge (FCI-IGP) at a trial and independently, and without consultation with the appointed International FCI-IGP Judge or any other person, marks the competitors in the Trial as if he were the appointed Judge. A Learner Judge's marks will have no bearing on the results of, or the awards made at a Trial and are not to be made known to the competitors. The Learner Judge's marking is solely to enable him to prepare a report as described in these Regulations.
- 3.6.2 Before a person can act as a Learner Judge (FCI-IGP) he must:
- 3.6.2.1 Have Qualified One (1) dog to at least FCI-IGP Grade 3 level.
- 3.6.2.2 Be proposed by letter from a KUSA affiliated FCI-IGP Training Club which hosts KUSA licensed FCI-IGP trials and be accepted by, the Provincial Council FCI-IGP Sub-committee in which area he resides. Where there is no such Provincial Council FCI-IGP Sub-committee, the proposal is to be made directly to the National Council FCI-IGP Sub-Committee. Where there is no such National Council FCI-IGP Sub-committee, the proposal is to be made directly to the KUSA.
- 3.6.2.3 Make an application in writing to the Provincial Council FCI-IGP Sub-committee in which area he normally resides. Where there is no such Provincial Council FCI-IGP Sub-committee, the proposal is to be made directly to the National Council FCI-IGP Sub-committee. Where there is no such National Council FCI-IGP Sub-committee, the proposal is to be made directly to the KUSA.
- 3.6.2.4 Pass a written examination with a pass mark of 80%, consisting of:
- A. A sixty (60) mark paper on both Schedule 03, the Temporary Exclusion Order (TEO) Manual and Schedule 09 Appendix B, to be provided by the Judges Education Council
- B. Forty (40) questions from Schedule 5B (2) (FCI-IGP) which shall be set by the National IGP Convener to meet FCI Requirements
- C. Ten (10) questions on Anatomy, Conformation and motion (dynamics) of dogs which shall be set by the National IGP Convener to meet FCI Requirements
- For standardisation, this examination is to be set by the National FCI-IGP Sub-committee. The examination is to be marked by the National FCI-IGP Sub-committee. If no committees exist, the KUSA shall oversee this. In all cases the exam shall be set and marked by a KUSA Licensed Judge (FCI-IGP).
- 3.6.2.5 Learner Judges have three (3) years to complete their practical, failing that they will have to redo the theoretical examination. This will be taken from date the Theoretical Examination is written.
- 3.6.3 **National Organization FCI-IGP Judges Qualification Route A**

The Provincial Council FCI-IGP Sub-committee, or where there is no such committee, the National Council FCI-IGP Sub-committee, or where there is no such committee, the KUSA, will then allocate the Learner Judge to a Licensed Judge (FCI-IGP). No more than two (2) people may be Learner Judges at any single trial.

- 3.6.4 The learner judge have to submitted a written report and his mark sheets. The report has to justify the marks allocated on the mark sheet, describing at least 15 dogs. This report has to cover at least (10) dogs participating in grade 3 and the rest can be made up by any combination of Grade 1, 2 and 3 dogs. The fifteen (15) dogs the Learner Judge has to report on can be accumulated over several trials as long as the minimum number of entries as set out in 3.6.9 are met. Within thirty (30) days of the Trial, the Learner Judge must submit his report to the Officiating Licensed Judge.
- 3.6.5 The officiating KUSA International FCI-IGP Licensed Judge shall, within 30 days of receiving the report, submit the report and mark sheets to the Provincial FCI-IGP Sub-Committee, together with the Licensed Judge's comments on the Learner Judges performance. The reports, mark sheets, Officiating KUSA Licensed Judge's comments, together with the Provincial FCI-IGP Sub-Committee letter of dis/approval will be forwarded to the National FCI-IGP Sub-Committee, or where there is no such committee, to KUSA, and recorded before being forwarded to KUSA for ratification.
- 3.6.6 In cases of doubt, the Chairman National Council FCI-IGP Sub-committee will contact the International FCI-IGP Licensed Judge to discuss any contentious points. If necessary, the Learner Judge may be asked to present himself to an Examining Committee composed of two (2) International FCI-IGP Licensed Judges appointed by the National Council FCI-IGP Sub-committee, who will then discuss with him the doubtful points in the report. The results of this meeting will decide whether the report is passed or failed. Where necessary this may be done by electronic means.
- 3.6.7 The above system will apply to all reports.
- 3.6.8 All reports become effective when received by KUSA and tabled by the Executive Committee of the KUSA.
- 3.6.9 No report by a Judge/Learner Judge shall be considered unless a minimum of four (4) dogs competed and are reported on in detail. The report must contain detailed comment on the performance of all the dogs entered in the trial.
- 3.6.10 When a Learner Judge's report is approved; his Workbook must be endorsed accordingly by the Chairman of his Provincial FCI-IGP Sub-Committee. Where there is no such Provincial Council FCI-IGP Sub-Committee, the endorsement is to be made by the Chairman of the National Council FCI-IGP Sub-Committee. Where there is no such National FCI-IGP Sub-committee, the endorsement is to be made by the KUSA. When the requirements as set out in 3.6.4 are met, the Judge will send the endorsed Work book to KUSA for the issue of his FCI-IGP Judge's Licence. No Judge shall accept an appointment to judge any Trial for which his Work book has not been endorsed.
- 3.6.11 **National Organization FCI-IGP Judges Qualification Route B.**

Learner Judges will be given the opportunity to become Licensed FCI-IGP National Organization Judges by participating successfully completing the following process.

- A. Attend a Judges seminar presented by the FCI Utility Dog Commission area representative.
- B. Judges independently a minimum of 5 dogs in FCI-IGP 3 conditions at a workshop during the FCI Judges seminar weekend.
- C. Write a report, the report must contain detailed comment on the performance of all 5 dogs.
- D. FCI-IGP Judges Qualifying Panel consisting of:
 - FCI Utility Dog Commission area representative for Africa.
 - Two senior Licensed KUSA FCI-IGP Judges. This FCI-IGP Judges Qualifying panel will scrutinize the Learner Judges Mark sheets. If found to be acceptable the Learner Judge will be asked to submit a written report within 30 days of the workshop. This report will be scrutinised by the two local judges on the FCI-IGP Judges Qualifying panel.

The National FCI-IGP Subcommittee must receive the reports for ratification and send their findings to KUSA for the issuing of the Licence within 30 days of receiving the reports.

- 3.6.12 All locally domiciled Judges shall be members in good standing of the Kennel Union and shall be over the age of eighteen (18) years at the time when formal studies or activities towards judging qualifications commence, and/or any judging is undertaken.
- 3.6.13 Appointment of Judges normally resident outside the area of jurisdiction of the KUSA will be considered by the Executive Committee of the KUSA in the light of the Judge's qualifications recognised by the appropriate canine authority in the Judge's country of permanent residence and in terms of Schedule 3 Regulation 34.4.
- 3.6.15 Whenever an exam must be set or marked or a report be assessed by any Subcommittee either Provincial or National, such committee must have as a member a licensed KUSA FCI-IGP 3 Judge. In the event that this is not possible the Subcommittee or KUSA shall refer the tasks of assessment or scrutiny of reports, setting and marking of exams to a KUSA licensed FCI-IGP 3 Judge for recommendation of approval or rejection to KUSA.
- 3.6.16 **Qualification of International FCI-IGP Judges**

In addition to one's duties as an International Performance judge:

- a. Assist in the training of local KUSA FCI-IGP Learner Judges:
 - Afford Learner Judges the opportunity to do their practical examination with him/her.
 - To establish the Learner Judge's skill to observe the dog under scrutiny and weigh it against the International Utility Dogs Regulations.
 - To observe the Learner Judges skill to provide verbal critique.
 - To provide practical training to the Learner Judge if any shortcomings are observed.
 - To scrutinise the Learner Judge's report ensuring that a factual and correct report is submitted.
 - To make recommendations to the NIGPSC.

- b. Assist in the training and qualification of helpers.
 - To act as a Qualification Panel member in Tutor and Helper Qualifications.
- c. Assist as a panel member for Helper selections for major events e.g., Meisterschaft.

To be recognized by the FCI as an international FCI-IGP performance judge, the applicant must meet the following minimum requirements:

1. Minimum age: having reached the South African legal capacity.
2. At the time of the application he must have qualified at least two dogs to the highest test level - FCI-IGP 3
3. Have judged, or entered a dog successfully at a national or international championship level
4. The applicant must be appointed by his FCI-Local Organisation (KUSA); he must have passed National FCI-IGP Subcommittee reviews.

The candidate must have:

- a) In-depth knowledge of the rules is one of the most important factors in assessing and qualifying a FCI-IGP performance judge. He must know the FCI Working Dog Rules in their entirety and must be confident with each department, to be able to assess and make the right decisions.
- b) The practical training must enable the applicant to acquire complete knowledge of all provisions, as well as scenarios that may occur on the working field.

The practical training consists of the successful Judging of at least 10 competitions, in which the candidate is gaining confidence. This is a prerequisite for the written examination.

3.6.17 Qualification of Judges for all versions of BH and Endurance Test

- 3.6.17.1 Candidate Judges for BH must follow the same acceptance procedure as for all FCI-IGP judges.
- 3.6.17.2 Once satisfying the acceptance procedure and having passed the learner judge close book theory exam, consisting of a) Sixty (60) marks on both Schedule 03, the Temporary Exclusion Order (TEO) Manual and Schedule 09 Appendix B questions will be provided by the Judges Education Council; b) Forty 40-mark questions on Schedule 05B(02) and Utility Dog Regulations as far as BH, AD, Article Indication are concerned; and c) Ten (10) questions on Anatomy, Conformation and motion (dynamics) of dogs (Note: B and C shall be set by the National IGP Convener to meet FCI Requirements), the candidate must act as a learner judge twice in any of the BH versions permitted, with a licensed KUSA FCI-IGP 3 judge.

- 3.6.17.3 The candidate must score the dogs entered and submit the score sheets to the officiating KUSA licensed FCI-IGP 3 judge.
- 3.6.17.4 The candidate must write a report on all the BH dogs entered in the trial.
- 3.6.17.5 These reports are to be handed to the officiating judge within 30 days who must in turn, consider and report satisfaction or not within 30 days of receiving them and if the reports are considered satisfactory, the same process as for FCI-IGP reports must be followed.
- 3.6.17.6 Judges passed for BH versions may only judge BH and Endurance Test and only if at least 4 BH entries are taking part.
- 3.6.17.7 In any event, a minimum of 8 BH dogs and at least 2 trials must be reported on before a candidate can be qualified.

3.7 Qualifying Workbook

- 3.7.1 All dogs must be registered or recognized with the KUSA before such card is issued. Proof of registration is to be given to the person who issues the card. For dogs that are registered on the Dogsport Record, the cards shall be marked by a double line crossing from top left to the bottom right.
- 3.7.2 All dogs must have an FCI-IGP Dog Qualifying Work book.
- 3.7.3 Affiliated clubs are restricted to issuing cards to their own members. Persons who are not members of the affiliated clubs may obtain Work books from their local Provincial Council FCI-IGP Sub-committee. In areas where there is no such Provincial Council FCI-IGP Sub-committee, the Work books may be obtained from the National FCI-IGP Sub-committee. Where there is no such National FCI-IGP Sub-committee, the Work books may be obtained directly from the KUSA.
- 3.7.4 The cards are to be issued by the Provincial Council FCI-IGP Sub-committee to affiliated clubs. Each card must bear a Provincial Council Alpha Indicator and be numbered and recorded in order to identify the issuing club. In areas where there is no such Provincial Council FCI-IGP Sub-committee, the Work books will be issued to affiliated clubs by the National FCI-IGP Sub-committee. Where there is no such National FCI-IGP Sub-committee, the Work books will be issued to affiliated clubs directly by the KUSA.

3.8 Marking of Competitors

As each dog completes a Phase, his score must be entered by the Judge on his score sheet and the score must be made known to the Handler. Scores may not subsequently be changed except to correct arithmetical errors. The scores awarded and commented on by the Judge should also be made known to the spectators as soon as it is practically possible.

3.9 Announcement of Results

After the scores are totalled and winners decided, before announcing the placings, the Judge will inform the public as to the total number of points required for a perfect score. He shall then announce the competitors who have qualified in the Trial and their score as well as the scores of other competitors.

3.10 Adhering to Regulations

No judge shall require any dog or Handler to do anything or penalise a dog or Handler for failing to do anything which is not required by these Regulations or by this Schedule 5B(2)(FCI-IGP).

3.11 Judge's Orders

Judge's verbal orders must be clear to enable everyone to follow the judging.

3.12 Events outside the Regulations

In the event of circumstances arising not covered by the Guidelines for International Working Dog Trials and International Tracking Dog Trials of the F.C.I. (Appendix B), then the KUSA Rules and Regulations apply. In the event of circumstances arising not covered by the KUSA Rules and Regulations, the Judge of the Grade will have discretionary powers to make a ruling subject to confirmation by the KUSA. In such instances the Judge must submit a written report setting out all details to the KUSA within fourteen (14) days of the Trial.

3.13 Judging FCI-IGP- FH

Only licensed FCI-IGP Judges may Judge FCI-IGP-FH.

4. APPENDIX

4.1 Appendix A – Commands in Different Languages

Verbal commands are brief orders given in a normal voice, consisting of one single word. The commands can be given in any language. The same command must be used for the same task at all times. Examples of these commands are given in the following table.

4.2 Notes for the execution of the REGULATIONS FOR THE INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIALS OF THE FCI.

4.2.1 The minimum number of participants is four handlers.

4.2.1.1 Participation of bitches in season. Whilst bitches in season may participate, they must do their B and C work after all other dogs entered, work is completed. Note: That a “none participating” dog or bitch is to be used for the distraction in B work.

- 4.2.1.2 Qualification in the part exercises is recorded in the official workbook. These may be added to whatever is offered on any schedule, and are stand alone. In particular, the FCI-UPr 1, FCI-UPr2 and FCI-UPr3, and FCI-APr 1, FCI-APr2 and FCI-APr3, can be worked with the FCI-IGP dogs being trialed for wherever there is a down stay and distraction.
- 4.2.1.3 Only qualifications listed in the REGULATIONS FOR THE INTERNATIONAL WORKING DOG TRIALS AND INTERNATIONAL TRACKING DOG TRIAL OF THE FCI may be entered in the workbook by KUSA recognized judges or judges from FCI member countries.
- 4.2.2 Regulations for the International Utility Dog Trials and the International Tracking Dog Trial of the FCI.
