## **DUTIES OF A KUSA REPRESENTATIVE**

Representatives of the Kennel Union of Southern Africa (KUSA Representative) are appointed in terms of Schedule 03 (Regulations for Championship Shows) Regulation 4 to which all other Schedules in the KUSA Constitution are linked.

- 1. Anyone who is appointed as a KUSA Representative is required to be a member of KUSA in good standing at the time he/she undertakes his/her appointment, and A KUSA Representative may not enter, exhibit or handle a dog registered (or co-owned) in his name at any KUSA licensed event held at the same venue on the day that he is officiating, nor in the same discipline held under the same licence on any day.
- 2. The Representative's prime function is to observe that the show Rules and Regulations are complied with by the Show Committee. He must, therefore, be conversant with the regulations in Schedule 03 (Regulations for Championship shows) and if he is officiating at a show for one of the working disciplines, with the relevant schedule/s for that Show. <u>He is not authorised to interfere in any way with the running of any show.</u> He may, if he observes any breach of the Regulations, bring this to the attention of the Show Manager and/or Show Secretary so that the breach may be rectified but he may not make rulings about or be involved in any breach of the regulations.
- 3. The KUSA Representative has no power to approve or disapprove of any decisions made by the Show Manager, Secretary or Committee, which are taken on their own responsibility and initiative.
- 4. The KUSA Representative has no power to take any complaints or objections from any show official, exhibitor, handler or member of the public. Complainants should be referred to the Show Secretary. (As a point of information Objections to Dogs and Disqualifications fall under Schedule 03 Regulation 31 and Fraudulent or Discreditable Conduct of people under Schedule 03Regulation 37).
- 5. A KUSA Representative must be impartial and his conduct above reproach.
- 6. In order that a KUSA Representative cannot be placed in an embarrassing position due to possible conflict of interests or be accused of bias he should not accept an appointment if any member of his household is an exhibitor, handler, official of the show or show-holding club, nor should he be a committee member of the club to whom the licence is issued.
- 7. A KUSA Representative must not accept any gifts in cash or kind, which in any way could be interpreted as having, or could have, an influence on his reporting on the conduct of a show.
- 8. When completing the report form supplied it is particularly important to accurately reflect the number of exhibits present and absent for Specialist and Group Club Shows and KUSA Representatives should not leave this part of the Report blank or insert such words as "refer catalogue". KUSA Representatives must return the report form, completed in all details, to the KUSA Office within seven (7) days of the show at which they represented KUSA.
