The additions and amendments to the Articles and Schedules listed below were agreed to by the Federal Council at its virtual meeting of 30 July 2026. The Articles will become effective on **01 February 2027** (or as otherwise stated) and the Schedules on **01 October 2026** or as otherwise stated.

Clubs are reminded that in terms of Article 40 of the Constitution, Affiliated Clubs have the right to object to any proposed amendment or part thereof to the Articles, but this does not extend to the Schedules which are governed by Article 41 of the Constitution.
