## **SCHEDULE 05E(02B) – REGULATIONS FOR TKC DOG JUMPING INTERPROVINCIAL COMPETITION OF THE YEAR**

**(Effective 01.01.2023)**

### **1. LICENSING AND SHOW REGULATIONS**

The Regulations relating to licensing and all other matters to do with Shows as set out in Schedule 3, Regulations for Championship Shows and Schedule 4, Regulations for Non-Championship Shows, of the Constitution of the Kennel Union of Southern Africa shall apply to this Competition insofar as they are relevant to the TKC Dog Jumping Interprovincial Competition of the Year and insofar as they do not conflict with the specific terms of this Schedule 05E(02B).

### **2. SCOPE OF THE LICENCE**

A Club, which is qualified to hold a Championship Show in the calendar year in which it is intended to hold the TKC Dog Jumping Interprovincial Competition of the Year, may hold the event named in this Schedule in conjunction with such Championship Show, or separate therefrom.

### **3. ELIGIBILITY OF DOGS FOR COMPETITION**

The Competition shall be open to any dog registered with the Kennel Union of Southern Africa on its Breed Registers, Canine Dogsport Record or Non-registry Breed Listing, provided that its eligibility is not in conflict with the Regulations hereunder described and that it has not been disqualified or suspended from competition by the Kennel Union of Southern Africa. Competing dogs must have a valid Dog Jumping Record Card.

### **4. HOST CLUBS**

- 4.1. The Qualifying Host Clubs for the event described in this Schedule 5E(02B) are KUSA-affiliated All-breeds Clubs which hold Championship Shows within the KUSA Area of Jurisdiction as set out in Schedule 3.
- 4.2. The Finals of the TKC Dog Jumping Interprovincial Competition of the Year will be held at a Championship Show by an All-breeds Club selected by the TKC Kennel Club and notified to KUSA not less than six (6) months prior to the event taking place.

### **5. QUALIFICATIONS FOR ENTRY**

- 5.1. The Competition described in this Schedule is open to dogs as well as bitches and references to dogs shall be taken to include bitches.
- 5.2. **Selection of Provincial Council teams:**
  - 5.2.1 The dogs and handlers are to be nominated by their Provincial Council to compete in the TKC Interprovincial Dog Jumping Competition of the Year.

- 5.2.2 Each Provincial Council (DOGSPC, NAPC, KZNPC, WCPC, EC&BPC and FS&NCPC) will be entitled to enter one (1) team per height category (Small, Medium, Large).
- 5.2.3 Each team will consist of four (4) dogs and one (1) reserve of the same height category.
- 5.2.4 Dogs need to be in Grade 1 Dog Jumping in their respective heights in order to be selected.

## 6. CONDITIONS FOR ENTRY

- 6.1. Entry to the TKC Dog Jumping Interprovincial Competition of the Year will be by invitation from the TKC Kennel Club and will be sent to each Provincial Council Dog Jumping Sub-Committee.
- 6.2. Each Provincial Council will select its Teams, and will do its utmost to ensure that its selected Teams compete in the Competition.
- 6.3. As the Competition is a prestigious event, all competitors are required to dress in a manner befitting it.
- 6.4. It is a condition of entry that, when the events are sponsored, competitors may not use their dogs for the advertising of any product without prior permission having been obtained from the Sponsor(s) in writing.
- 6.5. If the event is sponsored, the competitor may not wear clothing or accessories displaying any branding which directly conflicts with the branding of the principal Sponsor of the Competition.

## 7. JUDGING, EVENT FORMAT & POINTS ALLOCATION

- 7.1. Each Team will compete against the Teams of the various Provincial Councils.
- 7.2. The services of a Licensed Dog Jumping Judge will be obtained for these Competitions, subject to such Judge being qualified and eligible in terms of Kennel Union Regulations.
- 7.3. All rounds will be run as per the Regulations of Schedule 05D.
- 7.4. The competition will consist of two rounds:
  - 7.4.1. First round – Table A
  - 7.4.2. Second round – Table B
- 7.5. Each dog in a Team will receive points based on its placing in the jump-off of the first round (Table A) and its placing in the second round (Table B).

<b>Placing</b>	<b>Allocation of points</b>
1 <sup>st</sup> Place	Ten (10) points
2 <sup>nd</sup> Place	Nine (9) points
3 <sup>rd</sup> Place	Eight (8) points
4 <sup>th</sup> Place	Seven (7) points
5 <sup>th</sup> Place	Six (6) points
6 <sup>th</sup> Place	Five (5) points
7 <sup>th</sup> Place	Four (4) points
8 <sup>th</sup> Place	Three (3) points
9 <sup>th</sup> Place	Two (2) points
10 <sup>th</sup> Place	One (1) point

- 7.6. Each dog's points will be accumulated to determine the final score per Team for the round.
- 7.7. The final placings will be determined by adding the points gained by each Team from each round. The Team with the most points will be declared the Winners.
- 7.8. Should two or more teams tie for any one of the final placings, each member of the team will select a dog to participate in a run-off. Should both dogs be eliminated, a further two dogs will be selected and the process repeated until a winner is declared.

## **8. PRIZES AND AWARDS**

- 8.1. The Provincial Council Team with the highest combined score after both rounds will be awarded the TKC Dog Jumping Interprovincial Trophy, together with a prize in the form of a tangible gift, voucher, or cash.

## **9. SPONSORSHIP**

The Competition may be sponsored permanently or on an annual basis by any entity acceptable to both the Federal Council of the Kennel Union of Southern Africa and the Host Club. In the years when the event is sponsored, the Sponsor's name may be couple to that of the Competition. Should either the Club or the Sponsor at any stage choose to disassociate itself from the Competition, this must be done in a manner as not to prejudice the holding of the event in that year or any succeeding years. For this reason, a contract between the Club and any Sponsor needs to be in place, clearly setting out the rights and obligations of both, should either, or both, elect to withdraw from association with this Competition.
