

## SCHEDULE 5E (15) REGULATION 1.3

### THE RULES AND REGULATIONS GOVERNING THE SUPREME BULL TERRIER OF SOUTHERN AFRICA AND BULL TERRIER MAJOR TROPHY SHOW

(Effective 01.04.2017)

**NOTE: All Shows are held in the year following that in which they are named (e.g. The 2004 Show is held in 2005)**

#### 1. LICENSING AND SHOW REGULATIONS

This Show is held under a KUSA issued Open Show license.

The regulations relating to licensing and all other matters to do with the Shows as set out in Schedule 3 – Regulations for Championship Shows (Breed) and Schedule 4 – Regulations of Non-Championship Shows (Breed) of the Constitution of the Kennel Union of Southern Africa (herein after referred to as KUSA) shall apply to this competition and as far as they can be relevant to the **SUPREME BULL TERRIER OF SOUTHERN AFRICA COMPETITION and BULL TERRIER MAJOR TROPHY SHOW** and as far as they do not conflict with the specific terms of this Schedule 5E (15), Regulation 1.3.of the KUSA Constitution.

#### 2. SCOPE OF THE LICENSE

The South African Bull Terrier Club being a KUSA affiliated club who under the KUSA Constitution is licensed to hold Open Shows may hold the Supreme Bull Terrier of Southern Africa Competition and Bull Terrier Major Trophy Show (the Show) under such an Open Show license in the stead of any one of the Open Shows in a calendar year.

3. Any Bull Terrier which is registered with KUSA in the Breed Register and which has qualified in terms of the Regulations hereunder described and which has not been disqualified or suspended from competition by KUSA, may enter the Show.

#### 4. HOST CLUB

Until or unless this Schedule 5E (15), Regulation 1.3 is amended or altered the Host Club for the event shall be:  
**THE SOUTH AFRICAN BULL TERRIER CLUB (hereinafter referred to as “the Club”)**

#### 5. ENTRY QUALIFICATIONS, CONDITIONS AND FEES OF THE SHOW

5.1 Any Bull Terrier which is registered with KUSA in the Breed Register and has qualified in terms of this Schedule to enter for the Show may enter the Show.

5.2 This Show is open to all Bull Terriers that have been awarded a Best of Breed, Reserve Best of Breed, a Challenge Certificate or under a Recognition of Merit Award (ROM) judge, a Reserve Challenge Certificate, at any Championship Show held under KUSA Rules and Regulations, during the year preceding the Show, starting on 1 January and ending the 31 December annually.

5.3 All previous winners of Dog and Bitch of the Year awards automatically qualify to enter for the Show without winning any of the qualifying awards mentioned in the Regulations 5.2 of this Schedule.

5.4 Exhibitors are required to complete an entry form as prescribed by the Show organizing committee and to dispatch such completed entry form together with the entry fee as indicated on the Official Show Schedule and all other documents and colour photographs not larger than postcard size and in standard or digital format, required for entry of this Show, to the secretary of the organizing committee, before the closing date as indicated on the said Schedule. Proof of qualification for the Show in terms of Regulation 5.2 and 5.3 of this Schedule must accompany the entry form before the entry will be accepted.

5.5 It is a condition of entry, that when the event is sponsored, exhibitors may not use their dogs or any award gained in the event named in this Schedule for the purpose of advertising any product without the permission of the Sponsor having first been obtained in writing.

- 5.6 Attendance by all exhibitors of the Show shall be at their sole expense.
- 5.7 The Club shall from time to time, determine entry fees for the Show and they shall be included in the Official Show Schedule.

## 6. ORGANIZING COMMITTEE

- 6.1 For the purpose of presenting, administering and regulating the following years Show, an organizing committee shall be convened annually before the the 30<sup>th</sup> day of April, but only after the previous years Show has been held.
- 6.2 The organizing committee shall consist of the representative or his/her alternate from each of those specialist Bull Terrier clubs affiliated to KUSA that have paid the annual affiliation fee to the club in order to become a member club of the organizing committee, as well as the SA Bull Terrier Club chairman, who shall also act as the appointed representative of the SA Bull Terrier Club and the SA Bull Terrier Club secretary, who shall act on this organizing committee as the secretary.
- 6.3 Each fully paid up member club of the organizing committee shall appoint a club representative to represent their club on this committee. All appointed representatives must, apart from their member club, also be a member of the Club, in good standing.
- 6.4 Organizing committee membership fees of those specialist Bull Terrier clubs wishing to become members of the organizing committee, as well as the membership fees of member clubs' appointed representatives and their alternates, are due by the the 30<sup>th</sup> day of April, of each year and payable on demand to the secretary, who shall pay all fees and all other monies received for the purpose of the Show to the Club Treasurer. The Club committee shall annually review and determine all fees applicable in terms of this Schedule and shall not unreasonably refuse acceptance of proposals made by the organizing committee in this regard. The organizing committee shall keep a true record of their proceedings and a receipts and payments account reflecting all income and expenditure relating to the organizing and holding of each year's Show.
- 6.5 The organizing committee shall meet for the dispatch of business as often as is necessary, but not less than every three (3) months, provided that the secretary shall convene a meeting of the organizing committee within fourteen (14) days after receipt of a request by any two (2) member club representatives.
- 6.6 A quorum at any organizing committee meeting shall consist of not less than two (2) member clubs representatives and the SA Bull Terrier Club Chairman. The Club Chairman, or in his absence, a representative appointed by the Club committee for this purpose, shall at all times be the Chairperson of the organizing committee and no meeting may take place in the absence of the Club Chairman or his appointed representative. In the event of there being no quorum the meeting will be abandoned and reconvened at a place and time to be advised. In the event of the Club Chairman being unable to attend or is incapacitated in any way, the Club Committee must appoint an acting Club Chairman to fulfill duties as set out in this Schedule.
- 6.7 At all meetings of the organizing committee each member club representative shall have only one (1) vote.
- 6.8 All matters before the organizing committee shall be decided upon by a [simple] majority of the votes of those representatives present and voting. The Chairman shall have no casting or deliberative vote. The secretary shall have no vote. In the event of an equality of votes (i.e. a tie) the chairman shall allow further discussion on the matter or motion before hand, and call a re-vote. If after a re-vote there is still an equality of votes the *status quo* (the existing state of affairs) shall prevail.
- 6.9 The club secretary shall take down comprehensive minutes of all decisions taken at each of the meetings of the organizing committee and copies of the unconfirmed minutes are to be forwarded to each member club within fourteen (14) days of a meeting by pre-paid post, facsimile transmission, electronic mail or other transmission medium advised to the secretary by a member club.
- 6.10 Representatives of member clubs who are unable to attend meetings may submit advice, topics for discussion, requests or recommendations by means of facsimile, e-mail or post to the organizing committee for consideration. The respective member club committee must approve all the mentioned communications by member clubs and the chairman or secretary of the respective member club must sign all submissions. Such communication must be lodged with the secretary at least fourteen (14) days prior to a meeting, before being placed on the agenda.
- 6.11 In the event of no other Bull Terrier Club wanting to be part of the Show Organising Committee for any year, the Club (SABTC) shall be empowered to continue with the hosting of the Show for that year in its sole capacity and may appoint any number of people to be of assistance with the presentation of the Show. All decisions taken in terms of this Schedule must then be taken by the Club Committee and a simple majority decision on any aspect shall prevail.

## 7. FUNCTIONS AND POWERS OF THE ORGANIZING COMMITTEE

- 7.1 The organizing committee shall be empowered to carry out the administrative requirements necessary to ensure that the Show takes place on an annual basis.
- 7.2 The Show is to be held annually on the first weekend of February or such alternative date as decided upon by the organizing committee and approved by KUSA.
- 7.3 In particular, but without prejudice to this general authority, the organizing committee shall be required to carry out the following:
  - 7.3.1 Compile, in accordance with these Regulations and reviewed annually, a "Major Trophy Show Judges List" (herein after referred to as the final Judges List) and publish such a final Judges List in the November\December Club Newsletter for the purpose of informing all concerned as to the names of the Judges that are eligible to be drawn and appointed to judge in two (2) years time.
  - 7.3.2 Annually oversee the drawing of the names of three (3) Judges and two (2) Reserve Judges from the final Judges List, in accordance with the procedure as set out in this Schedule, to judge the Show in two (2) years time.
    - 7.3.2.1 For the first year of these rules and regulations coming into effect, being any Show following the acceptance of any amendment or change to this schedule by the Federal Council of Kusa, the judges shall be drawn twelve (12) months before the Show is to take place in accordance with the amended rules and regulations which amendments shall have retrospective enforcement and power and render any previous rules and regulation in this regard null and void
    - 7.3.2.2 For the following years all Judges shall be drawn twenty-four (24) months prior to judging the Show or such later date as the circumstance may determine in the sole discretion of the organising committee.
    - 7.3.2.3 All judges who have been drawn to judge, appointments are subject to KUSA clearance and a judging contract signed with the Club.
  - 7.3.3 Ensure that all awards made during the Show are consistent with those classes judged as referred to in Regulation 13 of this Schedule.
  - 7.3.4 Ensure that the Show is conducted in terms of KUSA Rules and Regulations.
  - 7.3.5 Specifically ensure that a Stud Dog and a Brood Bitch trophy be awarded annually in accordance with the point system provided for in Regulation 13.4.4 of this Schedule.
  - 7.3.6 From time to time, consider and approve Bull Terrier Specialist Foreign Judges for inclusion on the final Judges List, provided such a judge is recognized and approved to judge Bull Terriers in his/her country of permanent residence as well as subject to Regulation 8.5 hereof.
  - 7.3.7 Promote, encourage foster and advance a better co-operation between all Bull Terrier Clubs through the workings of the organizing committee.
  - 7.3.8 From time to time, invite additional representatives from any member club or any other person to the organizing committee, for the purpose of presentation, clarifications and views on particular issues pertaining to the Show. Any such additional representatives or persons invited to attend organizing committee meetings shall have no voting powers.
  - 7.3.9 The club secretary shall submit all recommendations and preliminary decisions made by the organizing committee concerning financial matters impacting on the Club to the South African Bull Terrier Club committee for final approval.

## 8. JUDGES

- 8.1 All local Judges selected and appointed under this Schedule (excluding Foreign Judges) must meet the following qualifying criteria in order to be placed on the preliminary and final Judges Lists by the organising committee and be allowed to judge this Show when selected in terms of the provisions of this Schedule. All Judges:
  - 8.1.1 Must currently be or have been a breeder of Bull Terriers and a KUSA qualified Bull Terrier Specialist Championship Show Judge on the KUSA Judges Panel for Bull Terriers before 1986, and those persons who had qualified as a Bull Terrier Championship Show Judge on the KUSA Judges Panel for Bull Terriers after 1986 whom must be or have been a breeder of Bull Terriers and also have passed a separate examination paper on the Bull Terrier Standard at Part II level of the KUSA aspirant breed judges qualifying programme, in order to be placed on any of the Judges Lists as anticipated in this Schedule.
  - 8.1.2 Must be a KUSA qualified Bull Terrier Championship Show breeder/judge on the KUSA Judges Panel for Bull Terriers, having passed a separate examination paper on the Bull Terrier Standard at Part II level of the KUSA aspirant Breed judges qualifying scheme.

- 8.1.3 Must have judged a minimum of three (3) Bull Terrier Specialist Championship Shows, or have judged Bull Terriers at five (5) Championship Shows where Challenge Certificates were available.
  - 8.1.4 At the sole discretion of the organizing committee, must have been active as one or more of the following; a Bull Terrier exhibitor, breeder, Judge or committee member of any specialist Bull Terrier Club registered with KUSA, for the past one (1) year preceding the selection process.
  - 8.1.5 At the sole discretion of the organising committee, must have directly and actively supported the Major Trophy Show event over the past three (3) years by either entering and exhibiting those Bull Terriers registered in his/her/their ownership at the MTS that have qualified for entry, or if the aforementioned is not applicable, by physically attending the MTS event and other ROM (Recognition of Merit) events presented by member Clubs.
- 8.2 Before the compilation of the final Judges List, a member club representative, or in the event of such a submission been made by a member of the club or by any Judges whose name appears or does not appear on the preliminary Judges Lists, the Chairman of the organizing committee, may put forward, on behalf of his/her club or any submissions made by a member of the club or by any Judge as contemplated herein, the name/s of any Judge or Judges for inclusion or exclusion on the final Judges List and those Judges names who are unable to comply with Regulation 8.1.1 to 8.1.4 herein for exclusion from the final Judges List. In order for a Judge's name to be considered for inclusion or exclusion from the final Judges List and made by any person other than a non-member club representative, fully motivated written submissions in this regard must be submitted to the organizing committee no later than the thirtieth (30<sup>th</sup>) day of September of each year for consideration. (This is to enable the organizing committee to place this matter on the Agenda for the October meeting and, if approved, allow the name to be included or excluded on the final Judges List which is to be published and circulated in terms of this Schedule).
- 8.3 A submitted name of any Judge may only be added to or removed from the final Judges List after deliberation by the organizing committee and when accepted by a simple majority of the eligible voters present and voting at the meeting of the organizing committee when this item appears on the Agenda. The decision of the organizing committee with regards to the names that shall appear annually on the Final Judges List shall be final and not subject to appeal, change or alteration by any authority.
- 8.4 All Foreign Bull Terrier Specialist Judges seeking approval to adjudicate at this Show must at the sole discretion of the organizing committee, be active within the Bull Terrier fraternity during the past five (5) years worldwide or in his/her country of permanent residence as an exhibitor, breeder or Judge.
- 8.5 For a Foreign Judge to be appointed to judge for a specific year, the following procedure applies:
- 8.5.1 A member club, may nominate a Foreign Judge to judge the show for a specific year. All nominations must be submitted in writing and must include a full reference to the minimum criteria as set out in Regulation 8.1.3 and 8.1.4 of this Schedule, and the Foreign Judge must be a Bull Terrier breeder/judge at Championship Show level in his/her country of residence and proof thereof must be submitted together with the nomination.
  - 8.5.2 Either the Judge or the nominating member club of the organizing committee must agree, in advance and in writing, to pay all travel and accommodation expenses pertaining to that Foreign Judge visiting South Africa, for the purpose of judging the Show, which undertaking must accompany the written nomination.
  - 8.5.3 A judging history and a brief resume of the Judge's experience of at least the past five (5) years, as well as a letter from the Judge acknowledging his/her willingness and availability to judge, must accompany the said nomination.
  - 8.5.4 Nominations must be received at least thirty-four (34) months prior to the Show for which the nomination is made in order for the organizing committee to evaluate the nomination and approve and appoint or reject the nominated. It must be noted that the approval and appointment of all Foreign Judges is subject to the provisions of Article 2.5.4 of the KUSA Constitution.
  - 8.5.5 Only one Foreign Judge at a time is allowed to judge at this Show for a specific year. All Foreign Judges appointed to judge may not be nominated to judge this event again for a period of ten (10) years.
  - 8.5.6 Foreign Judges approved and appointed in terms of this Schedule to judge the Show for a specific year is exempt from the normal selection procedure for Judges referred to in Regulation 9 of this Schedule and will be regarded as the first name in the draw in terms of Regulation 9.6 and 9.7 of this Schedule for that specific year.
- 8.6 Having judged at a Show held under this Schedule, a local Judge becomes ineligible to be placed on the Final Judges List in order to be selected to judge at any of the next two (2) succeeding Shows.

- 8.7 In the event that a Judge has accepted an appointment to judge the Show he/she shall, for a period of twelve (12) months prior to the day of the Show, refrain from showing, handling or exhibiting any Bull Terrier that has qualified or could qualify for entry to the Show and is going to be shown under that particular Judge at the Show. All appointed Judges must ascertain for themselves, before exhibiting a Bull Terrier at any show in the year prior to judging the Show, if that dog is going to be exhibited at the Show that he /she is to judge. Any breach hereof by an appointed Judge may, after following the procedure as set out in Regulation 8.10 of this Schedule, be disqualified from judging the Show, and accordingly be replaced with the Reserve Judge in terms of Regulation 9.9 of this Schedule.
- 8.8 Judges appointed to judge the Show may not accept judging appointments to judge any Bull Terrier class or Terrier Group that includes a Bull Terrier class at any Championship Show within a period of twelve (12) months and Non-Championship Show appointments within a period of twelve (12) months prior to the judging of the Show. Any appointed Judge contravening this clause may, after following the procedure as set out in Regulation 8.10 of this Schedule, be disqualified from judging the Show, and accordingly be replaced with the Reserve Judge in terms of Regulation 9.9 of this Schedule.
- 8.9 All Judges selected to judge the Show and whose appointments have been cleared with KUSA are required to sign and return to the secretary of the organizing committee the judge's contract within twenty (20) days after receipt thereof. Late submission of judging contracts may result in the Judge being deemed unavailable to judge, and accordingly be replaced with the Reserve Judge in terms of Regulation 9.9 of this Schedule.
- 8.10 Should the organizing committee, after it has been proven to their satisfaction and after due consideration of the facts presented, decide that a Judge is deemed to have breached his/her contractual obligations without sufficient cause, including those obligations mentioned in Regulation 8.7, 8.8 and 8.12 of this Schedule, disqualify a Judge from judging the Show, and disqualify and omit the name of such a Judge from the final Judges List for a compulsory period of ten (10) years, as the case may be. Any Judge affected under this clause must be afforded the opportunity to make written submission in rebuttal and/or in mitigation to the organizing committee within five (5) days after receiving a notice in this regard, before any final decisions are made in terms hereof. The decision by the organizing committee under this clause is final and the period of ten (10) years disqualification is obligatory and binding in all cases where a Judge was found to be in breach of his/her contractual obligations.
- 8.11 All appointed Show Judges must take cognizance of the contents of the Show Judges contract and the disciplinary rules as set out in the KUSA Constitution.
- 8.12 All Judges' contracts for this Show shall include an obligation to write a comprehensive and complete Judges' report, including comments on the movement of all the winning dogs and bitches of each separate class, as well as the "Best Mover" and "Best Head" classes, that they have judged at the Show and such a report must be submitted to the secretary within six (6) weeks after judging the Show. Failure to submit such a report within the said period will be considered a breach of contract and the procedure as set out in Regulation 8.10 of this Schedule must be strictly followed in all cases of non-compliance. Any extenuating circumstances must be taken into account by the organizing committee when dealing with a case of breach of contract under this Regulation.
- 8.13 The organizing committee or the Club shall not publish any Judge's report separately from that of the other two Judges' reports on a Show, in any Club Newsletter or on the Club website or any other publication, before all three the Judges reports have been received by the secretary, who shall then publish all three the reports simultaneously in the same publication and/or on the Club's official website.

## **9. SELECTION PROCEDURE FOR JUDGES**

- 9.1 When drawing the names of Judges that are to judge at the Show the organizing committee shall conduct this process in accordance with the procedures as set out in this Schedule, and no other.
- 9.2 Not later than thirty (30) months prior to the Show that is to be judged, the organizing committee shall compile a preliminary Judges List in accordance with the criteria a set out in Regulation 8.1.1 to 8.1.4 of this Schedule and publish such a preliminary Judges List in the Club newsletter before September of each year. A copy of this preliminary Judges List must be forwarded to the club committees of all member clubs as well as to all the judges whose names appear on the preliminary Judges List, for comment regarding the removal of a Judges name from the list or placement of a Judges name onto the list. Any affected Judge, club member, Bull Terrier club committee or any Judge whose name appears or does not appear on the preliminary Judges List in terms of this Schedule, may make written submissions to the organizing committee in this regard and as contemplated in Regulation 8.2 and 8.3 of this Schedule before the end of September of that year.
- 9.3 All Judges whose names appear on the preliminary Judges List must confirm in writing by no later than the end of September of each year to the Club secretary their availability and willingness to judge the Show in two (2) years time should their names be drawn for this purpose in accordance with the procedures as set out

in these Regulations. Each judge whose name appears on the preliminary Judges List must annually complete a questionnaire supplied by the Club and forward it together with the required information and supporting documentation and further confirm their availability to Judge in writing to the Club Secretary before the end of September of every year. Judges who fail to comply with any aspect of this requirement will not be placed on the final Judges List of that specific year and will be removed from all future Judges Lists as contemplated in this Schedule until they have fully complied with this requirement to the satisfaction of the organising committee.

- 9.4 At the October organizing committee meeting of each year the committee shall compile a final Judges List containing the names of those judges who have confirmed their availability to judge and whose names appeared on the preliminary list or whose names have been put forward for placement on or removal from the final Judges List and have been cleared by the organizing committee. This final Judges List shall exclude those names, which may not be submitted in terms of Regulation 8.6, 8.10 and 8.12 of this Schedule and those names of persons who have not confirmed in writing to the secretary of the organizing committee their availability to judge at a particular year's Show.
- 9.5 The secretary of the organizing committee shall ensure that the final Judges List is published in the November\December Club Newsletter as well as simultaneously on the Club's official website of each year and a copy of this final Judges List be forwarded to the club committees of all the KUSA affiliated Bull Terrier specialist clubs in Southern Africa before the end of December of each year.
- 9.6 All the names that appear on the final Judges List shall be placed in a container and the chairman of the Club shall draw five (5) names therefrom at the closure of the Show preceding the Show that will be judged in two (2) years time, and for the first year only, the same procedure shall be followed for the next Show (2005 Show) that will be judged.
- 9.7 The names of the first three (3) Judges, and in the event where Foreign Judge has been approved and appointed by the organizing committee to judge a specific Show, the first two (2) Judges drawn from the container will immediately be announced at the Show together with the name of the Foreign Judge that was appointed, if applicable, under the proviso that their appointments are first to be cleared with KUSA by the secretary of the organizing committee and they have signed and submitted their judging contracts within twenty (20) days of receipt thereof to the secretary. Only after receipt of the signed judging contract shall a judge be deemed to be officially appointed as the Judge for the said Show as per Regulation 8.9 hereof.
- 9.8 The secretary shall forward the judging contracts to the Judges within ten (10) days after their names have been drawn, announced and cleared with KUSA.
- 9.9 The persons whose names were drawn fourth and fifth from the container shall be the Reserve Judges, *in seriatim*, to act in the stead of any of the Judges being unable to judge at the Show, or who fail to sign their contracts within the required time, or who in terms of these Regulations have been disqualified to judge the Show or who have declined their appointment in terms of Regulation 9.10 of this Schedule or who has not been cleared by KUSA to judge the Show. All appointed judges KUSA clearance must be re-confirmed with KUSA thirty (30) days before the judging of the Show.
- 9.10 In the event that any appointed Judge, after the signing of the contract, becomes incapacitated or cannot judge the Show for whatever reason, the organizing committee will replace such an appointed Judge with a Reserve Judge, as per Regulation 9.9 here above.
- 9.11 In the event that the services of any one or both of the Reserve Judges are required in terms of Regulation 9.8, 9.9 and 9.10 of this Schedule, the organizing committee has the right to waive any of the conditions applicable to appointed Judges, in order to ensure that the services of the Reserve Judge/s can be secured and effected.
- 9.12 Should for any reason acceptable to the organising committee an insufficient number of appointed or Reserve Judges become available to judge at the instant Show, or for whatever reason acceptable to the organising committee certain judges or all judges cannot judge a specific Show, the organising committee reserves the right, subject to KUSA clearance and without following the selection procedure detailed in Regulation 8 and 9 of this Schedule, to appoint any Judge or Judges who comply with the criteria as set out in Regulation 8.1.1 to 8.1.4 of this Schedule to judge a Show, or to cancel the Show for that particular year.
- 9.13 It is a specific condition of this Schedule that no two Judges may judge any Show under this Schedule simultaneously with one another if they are husband and wife, life partners or co-habitants. In the event of a Judge's name being drawn from the container and renders the appointment in violation of this Regulation, such a Judge's name must automatically be put forward to judge the following Show for the next year, and another Judge's name be drawn from the container. In the event of the aforementioned occurring, the prescribed selection procedure for Judges as stipulated in regulation 9.1 to 9.6 of this Schedule is waived and such Judge must be regarded as the first Judge's name drawn to judge for the following year. No exceptions to this rule are permissible.

## 10. JUDGING PROCEDURE

All three (3) Show Judges will be used to judge the separate classes on a rotation basis during the judging of the Show. Two (2) of the three (3) Judges will judge each class, and no Judge may judge more than two (2) classes in succession with the remaining Judge always acting as the Referee. However, all three Show Judges shall judge the final class (The Supreme Bull Terrier of Southern Africa). The sequence of judging will be in accordance with Annexure A hereto, and the judges numbering (A, B or C) will be determined at the Show venue, before judging commences, by a draw.

10.1 It is a specific condition that no conferring of Judges will be allowed during the judging of the Show.

## 11. DRESS

When in the Show ring all exhibitors are required to wear a numbered disc provided, and the organizing committee and/or sponsor may require any additional item to be worn when the event is sponsored. All competitors are expected to be suitably dressed for the occasion as befits this prestigious event. T-shirts, shorts, jeans and takkies are not allowed. Shoes must be worn. The Show Manager may deny entry to the Show Ring to any exhibitor who does not comply with the provisions of this Regulation.

## 12. SANITATION

All competitors are required to remove any faeces deposited by their dogs and the cleaning of any grooming area used by them. Any competitor failing to do so is liable to instant disqualification from the Show.

## 13. PRIZES AND AWARDS

13.1 The following classes are to be judged for each sex separately and in the sequence as stipulated in Annexure A to this Schedule :

13.1.1 Best Import.

13.1.2 Ormandy Vase for South African bred Bull Terriers under two years of age on the Thirty first (31) day of December in the year immediately prior to that in which the Show is being held.

13.1.3 Ormandy Jug for South African bred Bull Terriers over two years of age on the Thirty first (31) day of December in the year immediately prior to that in which the Show is being held.

13.1.4 Best-Coloured, open to all coloured Bull Terriers including all imported coloured dogs and bitches.

13.1.5 Best-Coloured Bull Terrier of Southern Africa. Only the winners of the coloured Dog and Bitch Trophies are to compete for this award.

13.1.6 Best Imported Bull Terrier. Only the winners of the imported Dog and Bitch Trophies are to compete for this award.

13.1.7 Dog of the Year and Bitch of the Year, respectively. Only the winners of the Best Import, Ormandy Vase and Ormandy Jug are to compete for this award.

13.2 The following additional classes to those referred to in Regulation 13.1 hereof, are to be judged as indicated and in the sequence as stipulated in Annexure A to this Schedule:

13.2.1 The Supreme Bull Terrier of Southern Africa. Only the two (2) winners of the Dog of the Year and Bitch of the Year Trophies may compete for this award.

13.2.2 The Tom Horner "Tartary Trophy" for the "Best Mover". The Judges will make nominations for this award during the judging of the other classes.

13.2.3 The Montesano Trophy for the "Best Head". The Judges will make nominations for this award during the judging of the other classes.

13.3 Medals and /or rosettes will be awarded to all class winners. In those years when the event is sponsored, the Sponsors may present prizes and/or awards. All Trophies listed in the Office Schedule and/or the Show catalogue shall be on display at the Show, save and except where circumstances do not permit it. No winning exhibitor may remove a Trophy from the Show. By entering the Show exhibitors agree to photographs of winning dogs together with the Trophies that they have won, being taken at the Show. An official photographer will be provided for this purpose; however, private photographs may be taken under guidance of the Show manager.

13.4 The following Stud Dog and Brood Bitch awards and point system will be applicable for each calendar year separately:

13.4.1 The organizing committee together with the Club, shall ensure that Stud Dog and Brood Bitch Trophies are awarded annually after the completion of the Show governed by this Schedule, and after all the accumulated points for these awards, as stipulated in this Schedule for a specific year, have been calculated. These Trophies shall be presented to the respective breeder/s of the Stud

Dog and Brood Bitch whose progeny have accumulated the most points during a particular year, calculated from 1 January to 31 December, annually, including those points accumulated at the Bull Terrier Major Trophy Show held for that specific year, in accordance with the point system provided for in Regulation 13.4.4 of this Schedule, and no other.

- 13.4.2 Only Bull Terriers registered with the KUSA and shown in the KUSA area of jurisdiction are able to accumulate points for the purpose of these awards for their respective sire and dam. The sire and dam of the dogs that have accumulated points for these awards do not have to be resident in the KUSA area of jurisdiction in order for them to be able to win the Stud Dog and Brood Bitch awards and for their breeders to be presented with the relevant Trophies.
- 13.4.3 Although the Stud Dog and Brood Bitch competition is open to be awarded to any Stud Dog or brood Bitch worldwide, whether or not they are registered with KUSA, only their progeny registered with KUSA and shown within the KUSA area of jurisdiction, may accumulate points in terms of regulation 13.4.4 of this schedule for them towards these awards, and no other.
- 13.4.4 The following point system for the award of the Stud Dog and Brood Bitch trophies is applicable and no other:
  - 13.4.4.1 Four (4) points for a Champion, accumulated only in the year in which Championship status was obtained.
  - 13.4.4.2 Two (2) points for an Ormandy Vase winner.
  - 13.4.4.3 Two (2) points for an Ormandy Jug winner.
  - 13.4.4.4 Two (2) points for the Imported Dog and Bitch class winners, provided there is more than one (1) competitor per class, otherwise the two (2) points are accrued only if they also become Dog/Bitch of the Year.
  - 13.4.4.5 Three (3) points for Dog/Bitch of the Year class winner.
  - 13.4.4.6 Three (30) points for the Supreme Bull Terrier class winner.
- 13.4.5 As proof that a particular Bull Terrier has qualified for the status of Champion, either a Championship Certificate or a letter from KUSA stating that such a Championship Certificate will be issued to that Bull Terrier in the same calendar year as the last points towards Championship status were awarded, must be submitted to the secretary of the organizing committee before the thirty-first (31) day of December, or no points will be allocated in this category for that specific dog or bitch's sire or dam.
- 13.4.6 It remains the responsibility of the owner of each Champion Bull Terrier to inform the secretary of the organizing committee, in writing and before thirty-first 31 December of each year, that his/her dog/bitch has been granted the title of Champion during that current year and submit either a copy of the Championship Certificate or a letter from KUSA confirming that the title of "Champion" has been granted to that specific dog/bitch, before the organizing committee will accredit the Bull Terrier with the Stud Dog and/or Brood Bitch points, as referred to in Regulation 13.4.4.1 of this Schedule. In the event of the Bull Terrier being granted the title of "Champion" after the thirty-first (31<sup>st</sup>) December of the year in which the last points for the Championship status was obtained, no Stud Dog and/or Brood Bitch points will be awarded for that year or any subsequent years. Under no circumstances may any Stud Dog or Brood Bitch points from any dog/bitch be carried over to the /a following year.
- 13.4.7 Where the progeny of two Bull Terriers have accumulated an equal number of points in the Stud Dog and Brood Bitch awards, the Trophy shall be shared between the breeders of the said Stud Dogs and/or Brood Bitches.
- 13.4.8 The owners of the respective Stud Dog and Brood Bitch winners shall also be awarded a Trophy that is specifically presented for this purpose.

#### **14. SPONSORSHIP**

The Show may be sponsored permanently or on an annual basis by any organization acceptable to the Federal Council of KUSA and the Club. Should either the Club or the Sponsor wish to terminate their association with each other or the Show; this may not be done so as to prejudice the holding of this Show in the year or any succeeding years. For this reason a contract should be drawn up between the Club and any Sponsor establishing the rights and obligations of both, should either or both wish to withdraw from associating with this Show.

#### **15. AMENDMENTS AD CHANGES TO THIS SCHEDULE**

Any and all changes to this Schedule shall only come into effect after being approved by the Club at an AGM or Special GM and thereafter being accepted and ratified by the FEDCO of the KUSA on the date as determined by the FEDCO. In the event of such a change and/or amendment being related to the Judges selection procedure and the



compilation of the Judges List as contemplated herein, it shall have retrospective application in order to ensure that the following Judges selection procedure takes place in accordance with the change/s or amendment/s.
