  By entering, exhibiting or handling a dog at a show held under a Kennel Union licence we agree to be bound by the KUSA Constitution (as amended) in its entirety including all the schedules thereto (hereafter 'the Constitution').

  The attendance or exhibition of a dog that has either suffered from or been exposed to any infectious or contagious disease(s) within 6 weeks prior to the show, or that is suffering from such disease(s) at the time of the show, is contrary to the Constitution. Contravention of this regulation by the registered owner and/or handler is valued in the standard of the contrary by a Judge, or while the dog is in the ring or carrying out any licensed event as part of the competition, or engaged in practice prior to participating in the show, the registered owner and/or handler will ensure that the dog is at all times properly secured either within a suitable container or by a lead or leash that must at all times be either hand-held or securely anchored.

  The registered owner and/or handler is fully responsible for their dog's safety and behaviour at all times to the extent that they accept personal liability in respect of any daim made in respect of any damage or injury caused by their dog and/or their failure to adequately control their dog. They acknowledge that their dog has the ability to cause harm to other dogs, persons or property at the show.

  The registered owner and/or handler is fully responsible of their dog and/or and/or indemnifies KUSA, the affiliated Club conducting this Show, and the Officers of the Club against any and all claims of whatsoever nature and howsoever aris
