The presiding Judge will advise KUSA as to whether or not they should be reinstated.

\* In the event of licensed PD & TD3 judges not carrying out a judging appointment for a period of three (3) years a (1) questionnaire made up of questions pertaining to Schedule 3 and Schedule 9 Appendix B and Schedule 05B(1) be completed and submitted to the local governing body. The questionnaire must be updated from time to time, to ensure all new rules and regulations are included.
