The Club was informed on 27.06.2025 that they were still not in good standing, and could not be granted a licence. No licence was issued, however, the Club went ahead with the Show. WITHDRAWAL FROM COMPETITION</b></p> <p>18.1 Once a dog has entered the ring to be exhibited in one of the Classes for which he had been entered in advance of the Show, the dog shall be exhibited in all subsequent Classes entered and in all the Challenges and Competitions as contemplated by Regulations 21, 22 and 24 for which it has qualified at that Show.
