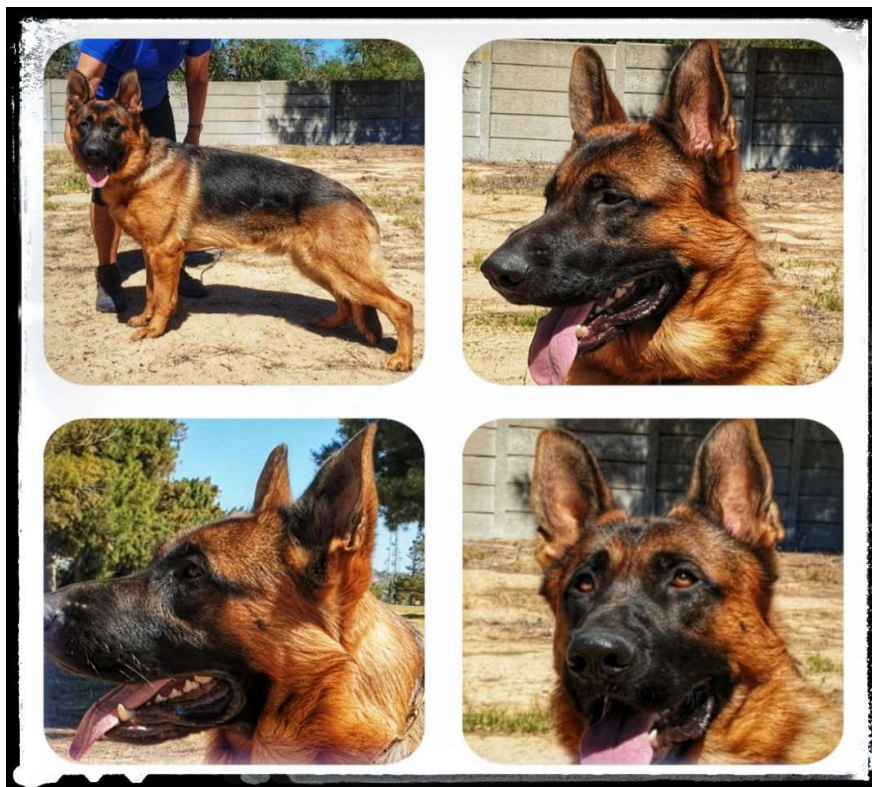

## **Breed:**

- I am a Senior Judge for the Working, Herding, Hound, Gundog and Terrier groups. I have judged Australian Shepherd and German Shepherd Championship Specialty Shows as well as Boxer, Corgi and White Swiss Shepherd Non-Championship Specialty Shows.
- I am qualified to award CCs as well as CACIBs for all the breeds in the above groups and judge Best in Show at Championship all breed shows.
- I am a German Shepherd Breed Specialist judge as well and have judged GSD Specialist Shows in Namibia as well as abroad.

## **Obedience:**

- I am a Senior licensed Obedience and Carting judge and am qualified to judge Canine Good Citizen.

I currently own 1 Alaskan Malamute and 1 Pembroke Welsh Corgi. I have been involved in the Alaskan Malamute breed for 25 years. I have also owned Tibetan Terriers and Bouviers.
