My career in dogs started in 1988 when I left school and had a few spare months before going to the army for my national service. After my army days, I got more involved in dog training and was introduced to IPO in 1993 by a lady with the name of Renette Gordon (Ferrenbach GSDs). She introduced me to the then TKC club and the bug bit as they say!

In 1993 I also got my first GSD (Sunbury Arrow) and in 1995 went on to 2nd place at the GSDFSA national championships with him. I went on to do many IPO3s with him and have had numerous dogs since then that I have competed with up to IPO/IGP3 level at various club trials, provincial and National Championships. I am still actively training 2 German Shepherds for the sport.

My first club was Koedoe park club in Pretoria where I learned to do helper work under the mentorship of Stefan Kiefer and later Wolfgang Straub.

As a helper, I qualified in 1995 as a trial helper and 2 years later as a tutor helper for the GSDFSA. I have since been actively training dogs for all level of training in bite work ranging from breed survey work to national trials to even preparing dogs for the WUSV World Championships.

I qualified as a IGP helper officially for KUSA in 2014 and in 2018 as a Tutor Helper. In 2016, I qualified as an IGP Judge.

I have officiated as a helper in numerous club trials, breed surveys and higher-level trials too. I did helper work for the GSDFSA National breed show on at least 10 occasions and have also been chosen as a helper for that organization's IPO nationals with a variety of European judges' multiple times. For KUSA, I have been the 2nd half helper for the 2016 Meisterschaft and more recently I was the 2nd half helper at our first KUSA selection trial a few years later. I have also had the honour to do helper work at many club trials and even Rottweiler breed assessments under various European judges as well as many local judges.

It is an honour and a privilege to have been entrusted once more with doing helper work for our 2021 KUSA IGP Meisterschaft.

I wish to thank the organizing committee for choosing me as a helper for this trial and I undertake to work all the dogs to the best of my ability and would also like to wish all competitors good luck and have fun with your dogs!
