### DECLARATION

By my signature to this form, and by inserting my full name and surname I, the Team Captain of the team detailed above, affirm that each team member has read and understood the full contents of the entry form, including the contents of this Declaration.  
 Each team member hereby declares that they understand and accept, in respect of the dog in their recorded or registered ownership or control as a handler, that;

1. Only Members of the Kennel Union shall be entitled to enter and to have dogs in their registered ownership compete in any Flyball Championship event licensed by KUSA.
2. By entering, exhibiting or handling a dog at a show held under a Kennel Union Licence we agree to be bound by the KUSA Constitution (as amended) in its entirety including all the schedules thereto (hereafter the "Constitution")
3. The attendance or exhibition of a dog that has either suffered from or been exposed to any infectious or contagious disease(s) within 6 weeks prior to the show, or that is suffering from such disease(s) at the time of the show, is contrary to the Constitution. Contravention of this regulation by the registered owner and/or handler may result in disciplinary action in terms of Schedule 1 Rule 2.
4. These dogs are entered and exhibited entirely at the registered owner and/or handlers own risk. Accordingly, unless specifically authorised to the contrary by a Judge, or while the dog is in the ring or carrying out any licensed event as part of the competition, or engaged in practice prior to participating in the show, the registered owner and/or handler will ensure that the dog is at all times properly secured either within a suitable container or by a lead or leash that must at all times be either hand-held or securely anchored.
5. The registered owner and/or handler is fully responsible for their dog's safety and behaviour at all times to the extent that they accept personal liability in respect of any claim made in respect of any damage or injury caused by their dog and/or their failure to adequately control their dog. They acknowledge that their dog has the ability to cause harm to other dogs, persons or property at the show.
6. The registered owner and/or handler indemnifies KUSA, the affiliated Club conducting this Show, and the Officers of the Club against any and all claims of whatsoever nature and however arising that may be levelled against them, jointly or severally, in respect of any harm caused by their dog and/or any failure on their part to adequately control their dog.
7. The registered owner and/or handler is fully responsible and liable for any harm caused to any person, animal or property arising out of any action by any minor child for whom the registered owner and/or handler is legally responsible by allowing them to handle a dog for which the registered owner and/or handler is responsible.
8. The registered owner and/or handler indemnifies KUSA, the affiliated Club conducting this show, and the Officers of the Club, against any and all claims of whatsoever nature and howsoever arising that may be levelled against them, jointly or severally, in respect of any harm caused by any minor child for whom the registered owner and/or handler is legally responsible at the show.
9. The registered owner and/or handler confirms that this entry form and documentation are complete, and that the contents thereof are true and correct and entirely free of any false or inaccurate information.
10. Where any information in this entry form and documentation is inaccurate to any degree whatsoever, the registered owner and/or handler may be subject to disciplinary action in terms of schedule 1 Rule 2, and any awards and/or prizes may be withdrawn or cancelled.
