- **Washing or sanitising your hands regularly**

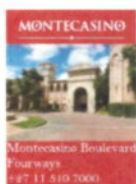




