With permission from Exco, the list of dogs to be submitted to the Agenda of Fedco 06-2025. CPA to draft a letter to send to owners informing them of their right to appeal the decision, should they wish to do so. On 03.04.2025, all Owners of dogs with TEOs over the 12-month limit were informed that their dogs would be tabled to Fedco 06-2025 for permanent disbarring. Several responses have been received, advising the present status of the dogs. To date, no appeals have been received. List will be tabled at Fedco 06-2025. Noted.
